## Agreement to the processing of personal data

We kindly ask you not to send us scanned copies of your personal documents containing personal identification numbers such as social security number (CNP), National ID or Passport number, etc.

In order to manage the selection process, Aspen Institute Romania will **transfer certain categories of personal data** of the applicants to Aspen Young Leaders Program to the members of the Selection Committee, who are graduates of Aspen Young Leaders Program and members of the Aspen Institute Romania.

Aspen Institute Romania respects the **rights** that the applicable legislation on personal data protection offers to all the subjected persons, i.e. the right to information, the right to access the data, the right to rectification, the right to delete the data ("the right to be forgotten"), the right to restrict the processing of personal data (starting from May 25th 2018), the right to data portability, the right to opposition, the right to not be subjected to an individual automatic decision, the right to refer to the Justice System or the National Authority on Surveillance of the Personal Data Processing, if considered to be necessary.
